AIRWORTHINESS DIRECTIVE

The following airworthiness directive (AD) may be applicable to an aircraft which our records indicate is registered in your name. ADs are issued pursuant to Canadian Aviation Regulation (CAR) 593. Pursuant to CAR 605.84 and the further details of CAR Standard 625, Appendix H, the continuing airworthiness of a Canadian registered aircraft is contingent upon compliance with all applicable ADs. Failure to comply with the requirements of an AD may invalidate the flight authorization of the aircraft. Alternative means of compliance shall be applied for in accordance with CAR 605.84 and the above-referenced Standard.

for which a Canadian Certificate of Airworthiness without restrictions is in force.

Compliance is required from 1 July 1970.

To ensure that Beech Model 3T aircraft meet a minimum standard of airworthiness acceptable to the Department, the maximum permissible all-up-weight for these aircraft shall be 8,750 lbs. The installation of modifications, Supplemental Type Certificates, Supplemental Type Approvals, etc., for the purpose of improving performance will not qualify Model 3T aircraft for an increase in all-up-weight in excess of 8,750 lbs. because of structural considerations.

This Directive becomes effective 1 June 1970.

Pursuant to CAR 202.51 the registered owner of a Canadian aircraft shall, within seven days, notify the Minister in writing of any change of his or her name or address.
