AIRWORTHINESS DIRECTIVE

The following airworthiness directive (AD) may be applicable to an aircraft which our records indicate is registered in your name. ADs are issued pursuant to Canadian Aviation Regulation (CAR) 593. Pursuant to CAR 605.84 and the further details of CAR Standard 625, Appendix H, the continuing airworthiness of a Canadian registered aircraft is contingent upon compliance with all applicable ADs. Failure to comply with the requirements of an AD may invalidate the flight authorization of the aircraft. Alternative means of compliance shall be applied for in accordance with CAR 605.84 and the above-referenced Standard.

This AD has been issued by the Continuing Airworthiness Division (AARDG), Aircraft Certification Branch, Transport Canada, Ottawa, telephone (613) 952-4357.

Compliance is required as follows unless already accomplished:

- (a) Prior to July 1, 1971, for those aircraft for which a Canadian Certificate of Airworthiness is in force; or,
- (b) Prior to the issuance of a Canadian Certificate of Airworthiness.

To ensure that these Ex-military aircraft meet a standard of airworthiness acceptable to the Department for the issuance of a Canadian Certificate of Airworthiness they must be modified in accordance with the following:

- (a) Bristol Report ER 2227; or,
- (b) Beech Drawing 18-5011; or,
- (c) a modification approved by the Chief Aeronautical Engineer, Department of Transport, Ottawa, as being equivalent to (a) or (b).

NOTE 1. Model 3T aircraft modified in accordance with (a), (b) or (c) above are not eligible for a Standard Airworthiness Certificate in the U.S.A.

NOTE 2. Models 3N, 3NM and 3TM aircraft are not eligible for a Standard Airworthiness Certificate in the U.S.A. unless modified in accordance with Beech Drawing 18-5011.

This Directive becomes effective April 1, 1970.

Pursuant to CAR 202.51 the registered owner of a Canadian aircraft shall, within seven days, notify the Minister in writing of any change of his or her name or address.
